Presenter: Waltraud (Wally) Prechter, President and Founder, Heinz C. Prechter Bipolar Research Fund

Wally Prechter is the widow of German-born entrepreneurial visionary Heinz C. Prechter. She founded the Heinz C. Prechter Fund for Manic Depression in November 2001, following her husband's suicide. The Fund is now at the University of Michigan Depression Center and known as the Heinz C. Prechter Bipolar Research Fund and Repository. Mrs. Prechter served as her husband's closest business advisor and confidant, quietly helping build the business empire that was Prechter Holdings. She has now taken center stage in a national crusade to cure bipolar disorder – lobbying Congress, courting medical specialists, and serving on former President Bush's New Freedom Commission on Mental Health. Mrs. Prechter will speak about her personal experience dealing with her husband's illness and suicide as well as the foundation she started in his memory.
